Assignor agrees to execute all rightful oaths, assignments, powers of attorney, and other papers necessary for Assignee to secure and maintain patent protection for the Invention and Patent with the United States Patent and Trademark Office ("USPTO") and with all other patent offices in all non-US countries to which the Invention may have intellectual property rights.
