and from said patents and patent applications, trade secret rights, trademark rights, mask works rights, and all other intellectual property rights and all business, contract rights and goodwill in, incorporated or embodied in, used to develop, or related to any of the foregoing and any registrations and applications for registrations of the foregoing throughout the United States of America and the world and any and all other applications arising therefrom, including any and all divisional applications, continuation applications, and continuation-in part applications (but only and solely to the extent such continuation-in part applications are described in the priority application to which such continuation-in part applications claim priority and such priority is not denied), of the Technology, and any and all patents to be issued and obtained therefor and thereon, in the United States and throughout the world, including all reissued Patents, and extensions thereof (collectively, the "Intellectual Property");

AND WE HEREBY agree to communicate to ASSIGNEE or its representative any facts known regarding the Technology whether or not patentable, which we may conceive, develop, make, produce or reduce to practice in whole or in part as a result of any employment, research, or activity involving or relating to the use of Purdue University resources; and agree to sign all lawful documents and make all rightful oaths and declarations relating to said Technology and Intellectual Property; authorize ASSIGNEE to insert herein application number and date of application, and agree to otherwise aid ASSIGNEE as necessary and desirable to:

1. Obtain, enforce, and maintain issued letters patent in the United States or throughout world, when reasonably requested to do so by ASSIGNEE such written documents and instruments as ASSIGNEE requests and giving testimony in support of ASSIGNEE's ownership, as may be necessary in ASSIGNEE's opinion to obtain and maintain patents in the United States of America and throughout the world.
2. Secure or aid in securing and maintain copyright protection in the Intellectual Property and assist ASSIGNEE or its nominees in filing applications to register copyright in the name of ASSIGNEE as owner in such Intellectual Property; and
3. Execute, acknowledge, and deliver to ASSIGNEE at its expense, such written documents and instruments and do such other acts as may be necessary in the opinion of ASSIGNEE, to vest

the entire rights, title, and interests in and to the Intellectual Property to ASSIGNEE and to confirm the complete ownership thereof by ASSIGNEE.

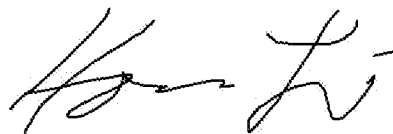

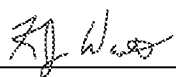
