
WHEREAS, the Supreme Court of the State of New York, County of New York, issued a judgment dated February 15, 2023 in a case with Index No. 655003/2019 (NYSCEF Doc. NOW, THEREFORE, in view of the ORDER, ASSIGNOR has assigned, transferred, and set over, and by these presents does hereby assign, transfer, and set over, unto the ASSIGNEE, its respective successors, legal representatives and assigns, all of ASSIGNOR's rights, titles, and interests in, to and under the PATENTS, including the right to sue thereon and any past or present damages arising therefrom, and all divisions, renewals, continuations and continuations-in-part thereof, and all Letters Patent which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which may hereafter be filed for the improvements in any country or countries, and all Letters Patent which may be granted for the improvements in any country or countries and all extensions, renewals and reissues thereof; and we hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for the improvements to the ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND ASSIGNOR HEREBY covenants that he has full right to convey the interests herein assigned, and that he will not execute any agreement in conflict herewith.

AND ASSIGNOR HEREBY further covenants and agrees that he will communicate to the ASSIGNEE, its successors, legal representatives and assigns, any facts known to him respecting the improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for the improvements in all countries.
