registrations and like rights of exclusion and for inventors' certificates for said inventions and improvements; and ASSIGNOR agrees for myself and my heirs, legal representatives and assigns, without further compensation to perform such lawful acts and to sign such further applications, assignments, Preliminary Statements and other lawful documents as the ASSIGNEE may reasonably request to effectuate fully this assignment.

And ASSIGNOR does further covenant and agree that I will, at any time upon request, communicate to the ASSIGNEE, its successors, assigns or other legal representative, such facts relating to said invention and Letters Patent or the file history thereof as may be known to me and testify as to the same in any interference or other litigation when requested, without further compensation but at the expense of said ASSIGNEE, its successors or other legal representatives.
