And we further agree to sign and properly execute such necessary and lawful papers for application for foreign patents, for filing divisions, continuations and continuations-in-part of said application for patent, and/or, for obtaining any reissue or reissues of any patent that may be granted for our aforesaid Invention, as the Assignee thereof shall hereafter require and prepare at its own expense.
