Pursuant to Title 8, Section 251(c) of the Delaware General Corporation Law (the "DGCL"), ExxonMobil Technology and Engineering Company, a Delaware corporation (the "Corporation"), hereby certifies the following information in connection with the merger of ExxonMobil Upstream Research Company, a Delaware corporation (the "Merging Entity"), with and into the Corporation (the "Merger"):

FIRST: The name and state of incorporation of each of each of the constituent corporations of the Merger are as follows:
