## **PATENT ASSIGNMENT**

### **RECITALS**

**WHEREAS**, Assignor previously acquired certain patents and patent applications, set forth on Schedule 1 hereto; and

**WHEREAS**, Assignor wishes to assign, convey and transfer to Assignee, and Assignee wishes to acquire, said patents and patent applications, including any and all patents and patent applications, invention disclosures, and such other patents as may issue thereon or claim priority under United States law or the law of any other jurisdiction or international convention, including but not limited to non-provisionals, continuations, divisionals, reissues, reexaminations, reviews, extensions, and substitutions, and any right, title and interest Assignor may have in applications to which such patents or patent applications claim priority, including, without limitation, those patents and patent applications set forth on Schedule 1 hereto (the "**Patents**").

**NOW, THEREFORE**, in consideration of the premises set forth above and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Section 1. Assignment. Effective as of February 8, 2023, the Assignor hereby sells, conveys, assigns, transfers and delivers to the Assignee, and its successors and assigns, any and all of Assignor's entire right, title and interest in and to the Patents, including, without limitation, those set forth on Schedule 1 hereto, together with (a) the right to apply for, make filings with respect to and maintain all registrations, applications and renewals thereof, and (b) the right to bring actions, defend against or otherwise recover damages or other compensation for past, present or future infringements, misappropriations, or other violations thereof, including the right to sue and obtain equitable relief in respect of such infringements, misappropriations and other violations, and the right to fully and entirely stand in the place of the Assignor in all matters related thereto.

Section 2. Cooperation. This Assignment has been executed and delivered by the Assignor for the purpose of recording the assignment herein with the appropriate government entity. Assignor hereby authorizes the United States Patent & Trademark Office and any other patent and trademark office or similar or comparable agency, office, register or registrar in any country or jurisdiction to record Assignee, and its successors and assigns, as the owner of the Patents in accordance with the terms of this instrument, and to issue any such registration, certificate or document in such country or jurisdiction in the name and for the benefit of Assignee, its successors and assigns. 


