SALES AGREEMENT

THIS AGREEMENT is made this 9th day of March, 2023, by and between Bull Gator Outfitters, LLC, of 5475 SW 75th St. #113, Gainesville, Florida, Sally Martin, and Tomas D. NOW THEREFORE, in exchange for a total purchase price of Twenty Thousand U.S. Dollars (\$20,000.00) paid by BUYER to SELLER, the receipt and sufficiency of which is hereby acknowledged by SELLER, SELLER and BUYER hereby agree to the following:

1.0 Intellectual Property Transferred

SELLER owns the following pertaining to its "Gator Hide" designs ("listed intellectual property"):

All new pattern designs or new product designs in SELLER's possession related to the Bull Gator pattern.

SELLER hereby sells to BUYER each and every right it possesses (including goodwill), whether held individually or otherwise, in and to the listed intellectual property, along with any other intellectual property it owns relating to the Bull Gator patterns. Further, SELLER sells to BUYER all rights to any other application for the protection of intellectual property which claims a filing date or any other benefit from the listed intellectual property. This sale is intended to be absolute, with SELLER retaining no rights whatsoever in the listed intellectual property.

2.0 Domain Names Transferred

SELLER hereby sells to BUYER each and every right it possesses to the following website domain names:

Martin, M.D. SELLER and BUYER understand and agree that there is a bank account held by Bull Gator Outdoors LLC with a small amount of money currently on deposit. This account and the funds it contains are not part of this sale and shall remain the property of its present owner.


6.0 Applicable Law



This Sales Agreement shall be governed by Florida law and jurisdiction and venue for any dispute arising thereunder shall reside solely with the state and federal courts of Florida.


