
**AFFIDAVIT IN ACCORDANCE WITH MPEP § 323.01(c)
REGARDING AN IMPROPERLY FILED AND RECORDED ASSIGNMENT**

I, Yiming Shen, do declare and state as follows:

1. I currently hold the position of Senior Patent Engineer of Synaptics Incorporated, which has a place of business at 1109 McKay Drive, San Jose, CA 95131.
2. An incorrect assignment document with erroneous information was recorded by Timothy D. Pesceyne of Blank Rome LLP in the above-referenced patent application on November 21, 2022 at Reel 061837/Frame 0643. This incorrect assignment document indicates a conveyance of a security interest from Coop Home Goods, LLC to Star Mountain Diversified Credit Income Fund, III, LP. Multiple attempts were made to contact Mr. Pesceyne, as well as Blank Rome LLP, to request that corrective papers be recorded, but no response has been received.

The true chain of title is shown in the Notice of Recordation dated October 1, 2021, setting forth the conveyance from the inventors (Wei-Lung Lee, Chih-Chien Chou, and Lin-Hsian Hsieh) to Synaptics Incorporated, recorded September 30, 2021 at Reel 057659/Frame 0603 (Exhibit 1). This true chain of title should not be considered altered by the incorrect assignment document.
4. Synaptics Incorporated has been, and continues to be, the owner of the present application (U.S. Appl. No. 17/490,330, now issued as U.S. Patent No. 11,614,813).
5. A corrected cover sheet is filed herewith.

6. Synaptics Incorporated hereby requests correction of this error, and the required fee under 37 C.F.R. §3.41, as provided under Section 323.01(b) of the Manual of Patent Examining Procedure, is submitted herewith in support of this request.
