**NUNC PRO TUNC CONTRIBUTION AGREEMENT AND ASSIGNMENT**

CONTRIBUTION AGREEMENT (“Agreement”) dated May 21, 2020 by and between AQUEST LLC, a Delaware Limited Liability Company (“Aquest”) and LiTL LLC, a Delaware Limited Liability Company (“LiTL”).

WHEREAS, Aquest and LiTL executed a Contribution Agreement dated December 18, 2009 in which “Aquest hereby contributes, transfers, conveys, assigns and delivers to LiTL, its successors and assigns, to have and to hold forever, all of its right, title and interest in and to the intellectual property assets listed on Exhibit A hereto (the ‘Assets’); and

WHEREAS, Aquest and LiTL intended that the Assets transferred from Aquest to LiTL by the Contribution Agreement included any and all inventions, discoveries, improvements, trademarks, and designs which are disclosed in the intellectual property assets identified in Exhibit A and Exhibit B, including any provisional, non-provisional, divisional, continuation, continuation-in-part, re-examination, substitute, renewal, reissue and all other applications for Letters Patent, utility models, industrial designs or similar intellectual property rights which have been or shall be filed in the United States, internationally, and in any foreign country or jurisdiction (“LiTL-related Assets”);

NOW, THEREFORE, in order to provide confirmation that the Contribution Agreement executed on December 18, 2009 transferred from Aquest to LiTL all right, title and interest to the LiTL-related Assets, and to quitclaim to LiTL, nunc pro tunc as of December 18, 2009, all right, title and interest to the LiTL-related Assets that Aquest may now or hereafter have to the LiTL-related Assets, Aquest and LiTL hereby agree as follows:

1. Aquest hereby (i) confirms that it contributed, transferred, conveyed, assigned and delivered as of December 18, 2009, and (ii) hereby quitclaims, contributes, transfers, conveys, assigns, and delivers *nunc pro tunc* as of December 18, 2009, in each case to LiTL its successors, assigns and legal representatives, all hereinafter referred to as the Assignee, its entire right, title and interest, if any, for the United States and all foreign countries, in and to any and all LiTL-related Assets including inventions, discoveries, improvements, trademarks and designs which are disclosed in Exhibits A and B attached hereto, and in and to all corresponding provisional, non-provisional, divisional, continuation, continuation-in-part, re-examination, substitute, renewal, reissue and all other applications for Letters Patent, utility models, industrial designs, trademark applications or similar intellectual property rights which have been or shall be filed in the United States, internationally, and in any foreign country or jurisdiction, including but not limited to China, Japan and Korea, on any of the inventions, designs and marks; and in and to all original and reissued patents and trademark registrations which have been or shall be issued in the United States or any other jurisdiction on the inventions and designs and marks, including the right to apply for patent rights in each foreign country and all rights to priority, including the right to claim priority for China, Japan and Korea; as well as the right to sue in its own name and recover damages for past infringement of any United States Letters Patent and foreign patent, including a reasonable royalty relating to provisional rights under 35 U.S.C. § 154(d) that have attached to any published United States patent application, on the inventions and designs;

2. Aquest agrees that the Assignee may apply for and receive Letters Patent and utility model and industrial design and trademark registrations for the inventions and designs and marks in its own name; and when requested, without charge to but at the expense of the Assignee, agrees to carry out in good faith the intent and purpose of this Assignment, by executing all non-provisional, divisional, continuation, continuation-in-part, re-examination, substitute, renewal, reissue, and all other applications for Letters Patent, utility models, industrial designs, trademarks or similar intellectual property rights which have been or shall be filed in the United States, internationally, and in any foreign country or jurisdiction, including but not limited to China, Japan and Korea on any and all the inventions and designs and marks, by executing all rightful oaths,

assignments, powers of attorney and other papers, by communicating to the Assignee all facts known to it relating to the inventions and designs and the history thereof, and generally by doing everything reasonably possible which the Assignee shall consider desirable for aiding in securing and maintaining proper protection for the inventions and designs and for vesting title to the inventions and designs and all applications for patents and all patents on the inventions and designs, in the Assignee;

3. Aquent requests the Director of the United States Patent and Trademark Office and foreign patent authorities to issue the Letters Patent or other intellectual property rights, including foreign patents, to the Assignee;

4. Aquent authorizes and requests Wolf, Greenfield & Sacks, P.C. to supply any missing application identification information or correct any errors in the application identification information provided on Exhibits A and B, whether discovered prior to or after recordation;

5. Aquent hereby covenants and agrees that it will, at the request of the Assignee and without further consideration, execute and deliver, and will cause its employees to execute and deliver, such other instruments of transfer, conveyance and assignment, and take such other action, as may be reasonably necessary to more effectively transfer, convey, assign and deliver to, and vest in, the Assignee, its successors and assigns, good, clear, record and marketable title to the LiTL-related Assets hereby transferred, conveyed, assigned and delivered, or intended so to be, and to put the Assignee in actual possession and operating control thereof, to assist Assignee in exercising all rights with respect thereto and to carry out the purpose and intent of this Agreement;

6. Aquent does hereby irrevocably constitute and appoint Assignee, its successors and assigns, its true and lawful attorney, with full power of substitution, in its name or otherwise, and on behalf of Aquent, or for its own use, to claim, demand, collect and receive at any time and from time to time any and all of the Assets, and to prosecute the same at law or in equity and upon discharge thereof, to complete, execute and deliver any and all necessary instruments of satisfaction and release;

7. This Agreement shall be governed by and construed in accordance with the internal laws of the Commonwealth of Massachusetts, without giving effect to any choice or conflict of law provision or rule (whether of the Commonwealth of Massachusetts or any other jurisdiction) that would cause the application of laws of any jurisdiction other than those of the Commonwealth of Massachusetts.
