- the right to extend to or register in or in respect of any country or territory in the world each and any of the Patents, and to extend to or register in, or in respect of, any country or territory in the world any patent or like protection granted on any of such applications;
- the absolute entitlement to any patents granted pursuant to any of the applications comprised in the Patents or filed as aforesaid;
- all statutory and common law rights attaching to the Trade Marks, together with the goodwill of the business relating to the goods or services in respect of which the Trade Marks are registered or used; and
- the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of the Rights, whether occurring before on or after the date of this assignment.

The validity, construction and performance of this Agreement shall be governed by English law and shall be subject to the exclusive jurisdiction of the English courts to which the Parties hereby submit, except that a Party may seek an interim injunction in any court of competent jurisdiction.


