FIRST: The name of the converting entity is Filtration Automation, Inc. (the "Converting Entity"). The Converting Entity is a Texas corporation organized pursuant to the TBOC. SIXTH: The Converted Entity shall be responsible for the payment of all applicable filing fees and franchise taxes, if any, of the Converting Entity and the Converted Entity shall be obligated to pay such fees and franchise taxes if the same are not timely paid.

SEVENTH: The conversion is to be effective when this Certificate of Conversion is accepted and filed by the secretary of state.
