The right, title, and interest is to be held and enjoyed by ASSIGNEE as fully and exclusively as it would have been held and enjoyed by ASSIGNOR had this assignment not been made.



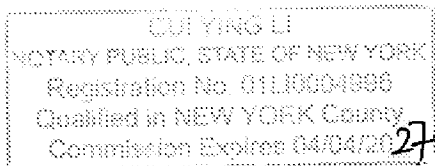


