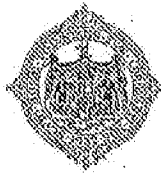

Platform-A Inc., a Maryland corporation, hereby certifies to the State Department of Assessments and Taxation of Maryland that:


1. The Amended and Restated Charter of Platform-A Inc. is hereby amended by deleting Article First in its entirety and replacing it with the following (the "Amendment"):

"FIRST: The name of the corporation (which is hereinafter called the "Corporation") is AOL Advertising Inc."


