ASSIGNORS specifically authorizes and directs the United States Patent and Trademark Office to issue any letters patent based on the assigned rights to the ASSIGNEE, record and maintain this assignment, and authorizes ASSIGNEE to specifically modify this agreement as necessary as ASSIGNEE deems prudent under the circumstances, so as to record this document and assign the Intellectual Property to ASSIGNEE.

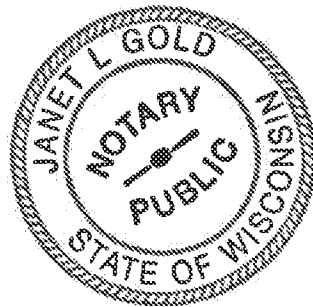

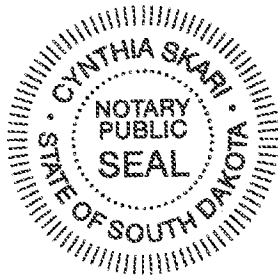
