ASSIGNMENT

2.0 ASSIGNMENT

2.1 ASSIGNORS sell, assign and transfer to ASSIGNEE all exclusive right, title and interest in and to the Invention.

2.2 ASSIGNORS assign to ASSIGNEE all of ASSIGNORS’ right, title and interest in and to the Invention in all foreign countries, including the right to apply for a patent or related legal rights in any foreign country and the right to all current and further applications for patents or related legal rights for the Invention, including the right to claim International Convention priority.

2.3 ASSIGNORS further transfer and assign to ASSIGNEE all causes of action, rights, and remedies arising under any such patent, related legal rights, or application prior to or after the Effective Date of this Agreement.


