**RELEASE OF
SECURITY INTEREST IN PATENTS**

This Release of Security Interest in Patents (“Patent Release”) is made as of June 22, 2023, by **DEUTSCHE BANK AG NEW YORK BRANCH**, a German banking corporation (the “Collateral Agent”) in favor of **GIANT HOLDINGS**, a Delaware corporation (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor granted the Collateral Agent, under the terms of the Patent Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to its Patent Collateral, including the Patents listed in Schedule 1.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in the Patents listed in Schedule 1 as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges (in each case, without any recourse to, or any representation or warranty by, the Collateral Agent) any and all of its interest in the Patents listed in Schedule 1 hereto, and assigns, transfers and conveys to the Grantor (in each case, without any recourse to, or any representation or warranty by, the Collateral Agent) any interest in such intellectual property, including the Security Interest.
