**TERMINATION AND RELEASE OF  
GRANT OF SECURITY INTEREST IN UNITED STATES PATENTS**

This **TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES PATENTS** (this “Release Agreement”), dated as of June 26, 2023, is made by **BANK OF AMERICA, N.A.**, a national banking association (“Grantee”) in favor of **SHEDRAIN CORPORATION**, an Oregon corporation (“Grantor”).

**WHEREAS**, Grantor and Grantee are parties to that certain Loan and Security Agreement dated as of March 25, 2021, in which the Grantor delivered to the Grantee that certain Memorandum and Notice of Security Interest in Intellectual Property dated as of March 25, 2021 (the “Memorandum”) whereby the Grantor granted the Grantee a security interest in certain Patents of the Grantor, including the patents and patent applications listed on Schedule A attached hereto (the “Secured Patents”) for recordation with the United States Patent and Trademark Office (the “USPTO”); and

**WHEREAS**, the Memorandum was recorded with the United States Patent and Trademark Office on March 25, 2021 at Reel 055721 / Frame 0330; and

**WHEREAS**, the obligations secured by said security interest have been paid in full or otherwise satisfied; and

**WHEREAS**, the Grantee has agreed to terminate and release its security interest and all of its right, title and interest in each of the Secured Patents, as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby agrees as follows:

1. **Release and Assignment**. The Grantee hereby discharges, terminates and releases its security interest in all of the Secured Patents, and the Grantee hereby assigns and transfers to the Grantors, without recourse, all of the Grantee’s right, title and interest in and to each of the Secured Patents and the related registrations and goodwill, effective as of the date set forth above.

2. **Further Assurances**. The Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release Agreement at the Grantors’ sole cost and expense.
