3. ASSIGNOR hereby and forever sells, assigns, transfers and sets over to ASSIGNEE all claims for damages by reason of past, present and future infringement of the Patents with the right to sue or take other legal action for and collect the same for the ASSIGNEE’S own use, whether in the United States or in any other country or place anywhere in the world.

4. This ASSIGNMENT and its provisions shall be binding upon ASSIGNOR’s successors and legal representatives, and shall inure to the benefit of the successors, legal representatives and assigns of ASSIGNEE and all future assigns thereof.

5. In the event that any provision, part or condition set forth in this Patent Assignment is adjudicated or declared to be illegal, unenforceable, invalid or void, in whole or in part, the remainder of this Patent Assignment shall be considered severable and shall continue in full force and effect to the full extent permitted by law.

6. ASSIGNOR covenants and agrees with the ASSIGNEE that the undersigned has the full right to convey the interest sold and assigned and has not executed and will not execute any writing or do any act whatsoever in conflict with the rights and interest assigned; and that the undersigned will at any time upon request, without further or additional consideration, but at the expense of the ASSIGNEE: execute such additional assignments and other documents and do such additional acts as the ASSIGNEE may deem necessary or desirable to perfect or confirm this assignment and the ASSIGNEE’S enjoyment of the rights acquired; and aid in enforcing any

rights accruing as a result of the Patents by giving testimony in any proceedings or transactions involving the Patents and by cooperating in the execution of documents, statements, affidavits, etc. that may be required in any such proceeding or transaction.
