For value received and pursuant to the *Order (A) Establishing Bid Procedures Related to the Sale of the Debtor's Assets, (B) Approving the Form and Manner of Notice Thereof, (C) Establishing Procedures Relating to Credit Bidding, (D) Approving the Proposed Sale and (E) Granting Related Relief* (the "Sale Order") entered at Docket No. 167 in Seller's Chapter 11 case pending in the U.S. Bankruptcy Court for the Southern District of Texas, Houston Division, (the "Bankruptcy Court") Case No. 18-33742 ("Bankruptcy Case"), Seller hereby assigns, sells and conveys the Property (as defined herein) to Buyer free and clear of all liens, claims encumbrances or exceptions to title.

The "Property" shall consist of all equipment, furniture, patents and other intellectual property described in Exhibit A attached hereto, as well as all books, documents, files, that are contained therein.

This Bill of Sale is the result of the withdrawal of an initial Competing Auction Bidder, resulting on Buyer/Stalking Horse Bidder acquiring the Property without need of an actual auction as detailed in Sale Order.


