## RELEASE OF FIRST LIEN SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF FIRST LIEN SECURITY INTEREST IN INTELLECTUAL PROPERTY, dated as of June 29, 2023 (this “Release”), is made by UBS AG, Stamford Branch, as administrative agent and collateral agent for the Secured Parties under the First Lien Pledge and Security Agreement referred to below (in such capacities, the “Administrative Agent”), in favor of Dreamwell, Ltd., a Nevada limited liability company (“Dreamwell”), Serta Simmons Bedding, LLC, a Delaware limited liability company (“SSB”), Tuft & Needle LLC, a Delaware limited liability company (“T&N”), and Tomorrow Sleep LLC, a Delaware limited liability company (“Tomorrow Sleep”, and together with Dreamwell, SSB and T&N, the “Grantors” and each, a “Grantor”). All capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to them in the Intellectual Property Security Agreement referred to below (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain First Lien Pledge and Security Agreement, dated as of November 8, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), by and among the Grantors and the Administrative Agent, the Grantors executed and delivered that certain First Lien Term Loan Intellectual Property Security Agreement Supplement, dated as of March 10, 2020 (the “Intellectual Property Security Agreement”), which was recorded with:

- (i) the U.S. Patent and Trademark Office (“USPTO”) on March 13, 2020 at Reel/Frame 052163/0152 with respect to patents owned by Dreamwell.

WHEREAS, pursuant to the Security Agreement and the Intellectual Property Security Agreement, each Grantor pledged, collaterally assigned, mortgaged, transferred, and granted to the Administrative Agent, on behalf of and for the ratable benefit of the Secured Parties, a continuing security interest in (the “Security Interest”) all of such Grantor’s right, title or interest in and to the IP Collateral, including, without limitation, the Trademarks listed on Schedule I hereto, the Patents listed on Schedule II hereto, and the Copyrights listed on Schedule III hereto; and

WHEREAS, the Grantors have requested that the Administrative Agent terminate and release the Security Interest in the IP Collateral.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (i) terminates the Intellectual Property Security Agreement, (ii) releases, discharges, terminates and cancels the Security Interest in the IP Collateral, and (iii) re-assigns to each Grantor any right, title or interest it may have in the IP Collateral of such Grantor, in each case without recourse to the Administrative Agent and without representation or warranty of any kind.




