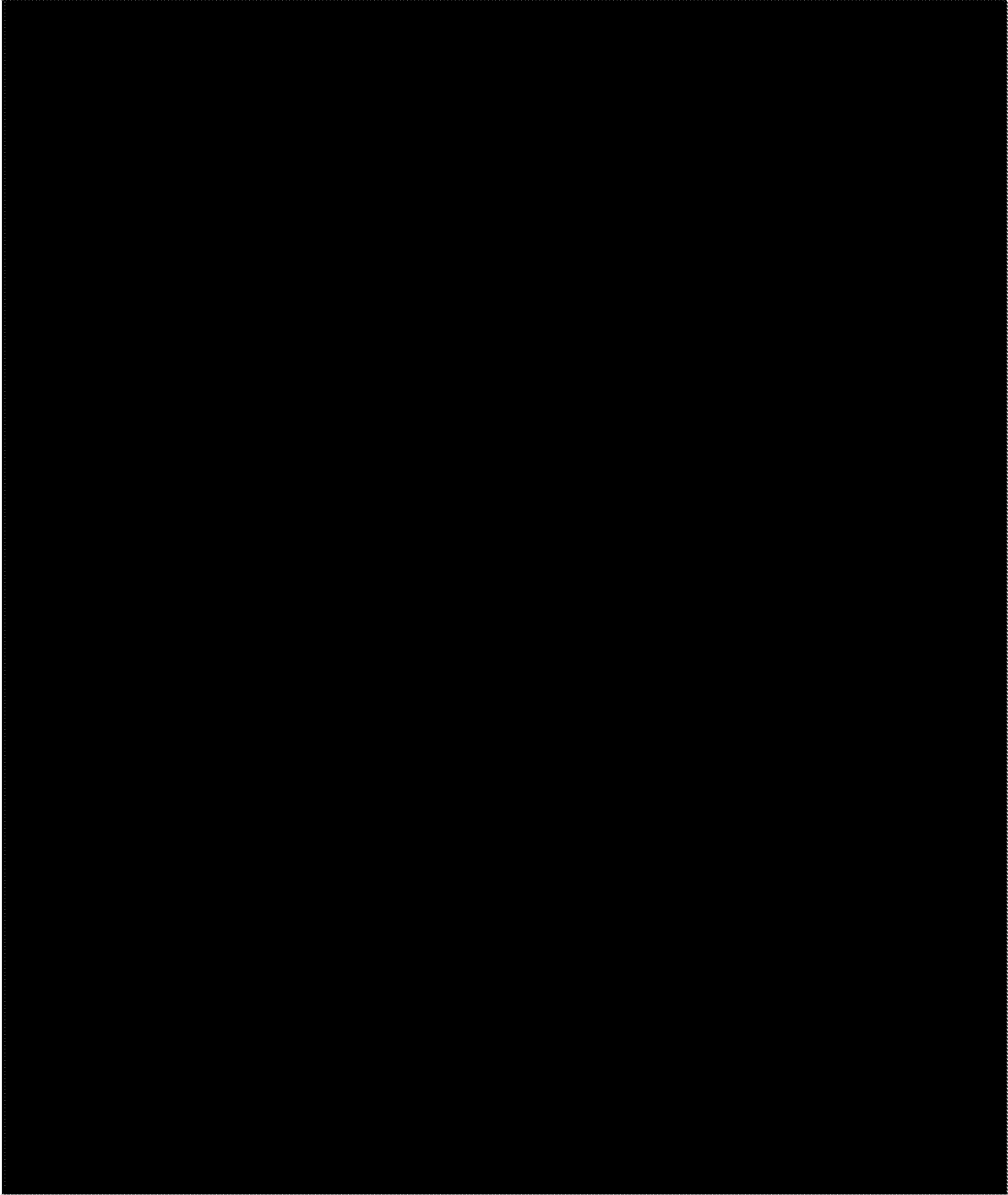


CLEARPATH ROBOTICS INC., a corporation incorporated pursuant to the laws of

- B. The Employee wishes to become an employee of the Corporation in that capacity.




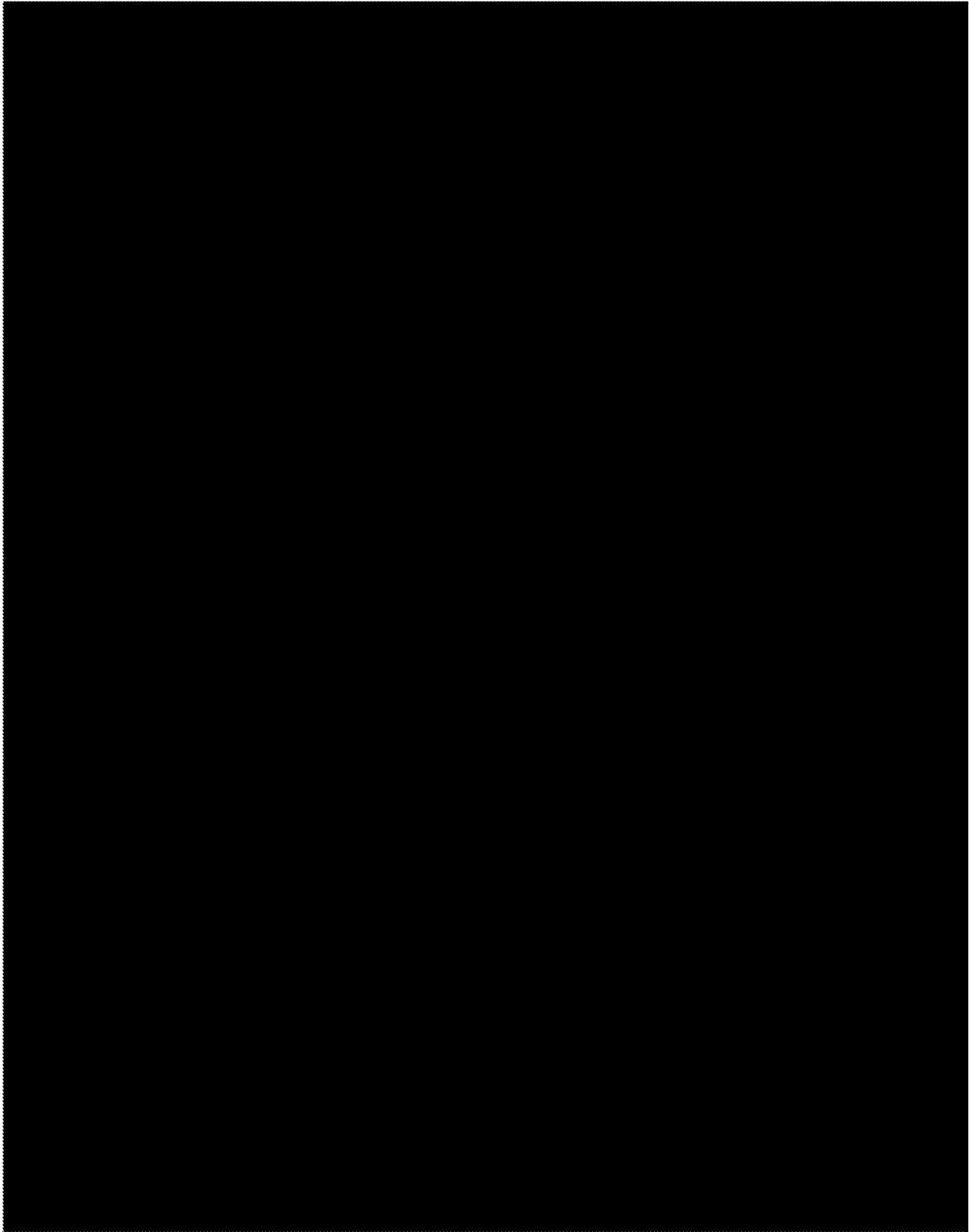


2.09 Intellectual Property Rights: The Corporation shall be the owner of all Work Products created by the Employee or in which the Employee assisted in the creation during the course of consulting for the Corporation. All intellectual property rights in such Work Products, including without limitation, all patents, trademarks, copyrights, trade secrets and industrial designs, shall be the exclusive property of the Corporation.

In the event that the Employee acquires any rights or interests in the Work Products or in any intellectual property rights relating to the Work Products, the Employee agrees to assign and by executing this Agreement does assign all such rights and interests to the Corporation. The Employee hereby waives any moral rights he may have in or to the Work Products delivered to the Corporation. The Corporation shall have the exclusive right to obtain copyright registrations, letters patent, industrial designs, trademark registrations or any other protection in respect of the Work Products and the intellectual property rights in the Work Products anywhere in the world. At the expense and request of the Corporation, the Employee shall both during and after his engagement with the Corporation, execute all documents and do all other acts necessary in order to enable the Corporation to protect its rights in such work products and the intellectual property rights in the work products.

As used in this Section, "Work Products" includes, without limitation, all techniques, drawings, algorithms, concepts, formulas, prototypes, software (both source and object code), specifications, designs, documentation, reports and customer lists and all know-how, techniques, research and development information, business data, technical data and other information relating to any of the foregoing (including without limitation associated goodwill and remedies against infringements thereof and rights of protection of an interest therein under the laws of all jurisdictions).
