FOURTH: The merger is to become effective upon filing of this Certificate of Merger.

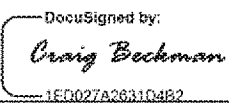

SIXTH: The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.

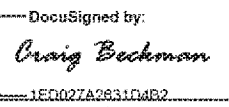
SEVENTH: A copy of the Merger Agreement will be furnished by the surviving corporation, on request and without cost, to any stockholder or member of any Constituent Entity.
