TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS**, dated as of July 28, 2023 ("Release"), is made by Bank of America, N.A., as Administrative Agent (as successor agent to Wells Fargo Bank, National Association (as successor-in-interest to Wachovia Bank, N.A.), as Administrative Agent ("Resigning Agent") pursuant to the Successor Agency Agreement dated as June 17, 2016 ("Successor Agency Agreement"), the "Successor Agent") in favor of Aerojet Rocketdyne, Inc. (as successor-by-merger to Aerojet-General Corporation), an Ohio corporation ("Grantor").

WHEREAS, pursuant to that certain Fourth Amended and Restated Security Agreement dated as of June 17, 2016 (as amended, modified, restated or supplemented from time to time, the "Security Agreement") by and among the Grantor, Resigning Agent, and others party thereto, Grantor granted to the Resigning Agent, for the benefit of the Secured Parties, a continuing security interest in, and a right to set off against, any and all right, title and interest of Grantor in and to all Patents, whether then owned or existing or owned, acquired or arising thereafter, including the patents and patent applications listed on Schedule A attached hereto (collectively, "Patent Collateral"); and

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered to Resigning Agent the Notice of Grant of Security Interest in Patents recorded at the United States Patent and Trademark Office ("USPTO") on May 21, 2007 at Reel 019317 Frame 0223 ("Notice");

WHEREAS, pursuant to the Successor Agency Agreement and the Notice of Succession of Agency (Intellectual Property) dated as of June 17, 2016 ("IP Agency Notice") each by and among the Resigning Agent and Successor Agent, the Resigning Agent ceased to be the Administrative Agent and was succeeded to and replaced by Successor Agent as the Administrative Agent, and the security interest granted in the Patent Collateral to the Resigning Agent pursuant to the Security Agreement and Notice, including the Patent Collateral listed on Schedule A attached hereto, was succeeded by and transferred to the Successor Agent; and

WHEREAS, the IP Agency Notice was recorded at the USPTO on June 20, 2016 at Reel 039079 Frame 0857.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Successor Agent, on behalf of the Secured Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement, Notice, or IP Agency Notice.

SECTION 2. Termination and Release. Successor Agent, on behalf of the Secured Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in, and the right to set off against, any and all right, title and interest of Grantor in and to the Patent Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Notice; and

(b) authorizes and requests the recordation of this Release with the USPTO at Grantor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the law governing the Security Agreement.

IN WITNESS WHEREOF, the Successor Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Patents to be duly executed as of the date first set forth above.
