CONFIRMATORY ASSIGNMENT

THIS CONFIRMATORY ASSIGNMENT is dated 18 May 2023

PARTIES:

1. **ORDAMO LIMITED**, a company incorporated and registered in England and Wales under company number 09635511, whose registered office is at 87 Arlington Road, London NW1 7ES (the **"Seller"**); and
2. **COMPURANTS LIMITED**, a company incorporated and registered in England and Wales under company number 05563170, whose registered office is at 87 Arlington Road, London NW1 7ES (the **"Buyer"**); and

BACKGROUND

- (A) The Seller transferred to the Buyer to certain patents, patent applications and trademarks to the Buyer by an Asset Purchase Agreement dated 5th April 2023.

AGREED TERMS:

1 INTERPRETATION

- 1.1 In this confirmatory assignment and its recitals and schedules, save where otherwise expressly provided or unless the context provides otherwise the following terms have the following meanings:

"Effective Date"

means the 5th April 2023 effective date of the Asset Purchase Agreement entered into between the Seller and the Buyer.

"Ordamo Trademarks"

means the trademarks listed in Schedule 1;

"Patents"

means the patents and patent applications listed in Schedule 2;

2 CONFIRMATORY ASSIGNMENT

- 2.1 For valuable consideration paid by the Buyer to the Seller pursuant to the Asset Purchase Agreement, the Seller confirms that it has assigned to the Buyer with effect from the Effective Date, absolutely with full title guarantee all its right, title and interest throughout the world in and to the Ordamo Trade Marks, including:
- (a) the absolute entitlement to any registered trade marks granted pursuant to any of the applications comprised in the Ordamo Trade Marks; and
 - (b) all statutory and common law rights attaching to the Ordamo Trade Marks, together with the goodwill of the business relating to the goods or services in respect of which the Ordamo Trade Marks are registered or used; and
 - (c) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action (including passing off) arising from ownership, of any of the Ordamo Trade Marks whether occurring before, on or after the date of this agreement.

- 2.2 For valuable consideration paid by the Buyer to the Seller, the Seller confirms that it has assigned to the Buyer, with effect from the Effective Date, absolutely with full title guarantee, all its right, title and interest in and to the Patents, and in and to all and any inventions disclosed in the Patents, including:
- (a) in respect of any and each application in the Patents:
 - (i) the right to claim priority from and to prosecute and obtain grant of patent; and
 - (ii) the right to file divisional applications based thereon and to prosecute and obtain grant of patent on each and any such divisional application;
 - (b) in respect of each and any invention disclosed in the Patents, the right to file an application, claim priority from such application, and prosecute and obtain grant of patent or similar protection in or in respect of any country or territory in the world;
 - (c) the right to extend to or register in or in respect of any country or territory in the world each and any of the Patents, and each and any of the applications filed as aforesaid, and to extend to or register in, or in respect of, any country or territory in the world any patent or like protection granted on any of such applications;
 - (d) the absolute entitlement to any patents granted pursuant to any of the applications filed as aforesaid; and
 - (e) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of the Patents or any patents granted on any of the applications filed as aforesaid, whether occurring before on or after the date of this agreement.

3 FURTHER ASSURANCE

The Seller and the Buyer shall do, execute and perform and shall procure to be done, executed and performed all such further acts, deeds, documents and things as may be required by law or as any party may require, whether on or after the date of this Agreement:

- (a) to implement and/or give effect to this agreement and the transactions contemplated by it; and
- (b) for the purpose of vesting in the Buyer the full benefit of the assets, title, rights and benefits to be transferred to the Buyer under this agreement.

4 GOVERNING LAW

This Confirmatory Assignment and all documents supplemental to it shall be governed by and construed in accordance with English Law.

5 COUNTERPARTS

This Confirmatory Assignment may be executed in any number of counterparts each of which when executed and delivered shall be an original, but all the counterparts together shall constitute one and the same instrument.
