THIRD AMENDED AND RESTATED CERTIFICATE OF INCORPORATION  
OF  
BEAM INC.**

Beam Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "**Corporation**"), does hereby certify as follows:

1. That, by written consent in lieu of a meeting, (i) the Board of Directors of the Corporation duly adopted resolutions, pursuant to sections 141(f) and 242 of the General Corporation Law of the State of Delaware, proposing and declaring advisable that the Certificate of Incorporation of the Corporation be amended, and (ii) the stockholders of the Corporation consented to said amendment in accordance with the provisions of section 228 of the General Corporation Law of the State of Delaware, as follows:

RESOLVED: That the Corporation's Third Amended and Restated Certificate of Incorporation be amended as follows:

1. By deleting Article I in its entirety and substituting for such paragraph a new paragraph as follows:

"The name of the corporation is Mobeus Industries, Inc. (the "Corporation")."

2. That the aforesaid amendment was duly adopted in accordance with the applicable provisions of sections 141(f), 228 and 242 of the General Corporation Law of the State of Delaware.
