**EXECUTION****INTELLECTUAL PROPERTY SECURITY AGREEMENT SUPPLEMENT (FISCAL YEAR 2023)**

WHEREAS, Kodak Alaris Inc., a Delaware corporation (the "**Grantor**"), owns the Intellectual Property Collateral (as defined below);

WHEREAS, (i) Grantor, among others, and The Board of the Pension Protection Fund, as the Original Lender, Agent, Security Agent (in such capacity, the "**Security Agent**") and Existing Loan Note Holder thereunder (in each case, by assignment), are parties to a Senior Facility Agreement dated September 29, 2020 (as amended by the Deed dated July 26, 2022, and as supplemented or otherwise modified from time to time, the "**Facility Agreement**"), and (ii) Grantor and Security Agent are parties to the Security Agreement dated September 30, 2020 (as amended, supplemented or otherwise modified from time to time, the "**Security Agreement**");

WHEREAS, pursuant to the Security Agreement, the Grantor has secured the Secured Obligations (as defined in the Security Agreement) by granting to the Security Agent as security agent for the Secured Parties (as defined in the Facility Agreement) a continuing security interest in personal property of the Grantor, including all right, title and interest of the Grantor in, to and under the Intellectual Property Collateral (as defined below), including the Patents and Trademarks acquired by Grantor in the fiscal year ended March 31, 2023;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor grants to the Security Agent, to secure the Secured Obligations, a continuing security interest in all of the Grantor's right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the "**Intellectual Property Collateral**"), whether now owned or existing or hereafter acquired or arising:

- (i) each Patent referred to in Schedule 1 hereto;
- (ii) each Trademark referred to in Schedule 2 hereto, and all of the goodwill of the business connected with the use of, or symbolized by, each such Trademark; and
- (iii) all proceeds of and revenues from the foregoing, including, without limitation, all proceeds of and revenues from any claim by the Grantor against third parties for past, present or future unfair competition with, or violation of, intellectual property rights in connection with any injury to, or infringement of any Patent or Trademark now owned or existing or hereafter acquired or arising, or any dilution of any Trademark now owned or existing or hereafter acquired or arising.

After the occurrence and during the continuance of an Event of Default (as defined in the Facility Agreement), the Grantor irrevocably constitutes and appoints the Security Agent and any officer or agent thereof, with full power of substitution, as its true and lawful attorney-in-fact with full power and authority in the name of the Grantor or in the Security Agent's name, from time to time, in the Security Agent's discretion, so long as any Event of Default shall have occurred and be continuing, to take with respect to the Intellectual Property Collateral any and all appropriate action which the Grantor might be entitled to take with respect to the Intellectual Property Collateral and to execute any and all documents and instruments which may be necessary or desirable to carry out the terms of this Intellectual Property Security Agreement Supplement and to accomplish the purposes hereof. Except to the extent expressly permitted in the Facility Agreement and Security Agreement, the Grantor agrees not to sell, license, exchange, assign or otherwise transfer or dispose of, or grant any rights with respect to, or mortgage or otherwise encumber, any of the Intellectual Property Collateral.

The foregoing security interest is granted in conjunction with the security interests granted by the Grantor to the Security Agent pursuant to the Security Agreement. The Grantor acknowledges and affirms that the rights and remedies of the Security Agent with respect to the security interest in the Intellectual Property Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

This Intellectual Property Security Agreement Supplement shall be governed by, and construed in accordance with, the laws of the State of New York. The Grantor agrees that any suit for the enforcement of this Intellectual Property Security Agreement Supplement may be brought in the courts of the State of New York or any federal court sitting therein and consents to the non-exclusive jurisdiction of such court and to service of process in any such suit being made upon the Grantor by mail at the address specified in the Security Agreement. The Grantor hereby waives any objection that it may now or hereafter have to the venue of any such suit or any such court or that such suit is brought in an inconvenient court.

This Intellectual Property Security Agreement Supplement may be executed in two or more separate counterparts, each of which shall constitute an original and all of which shall collectively and separately constitute one and the same agreement.

In case of any inconsistencies between the terms of this Intellectual Property Security Agreement Supplement and those of the Security Agreement, the Security Agreement shall prevail.

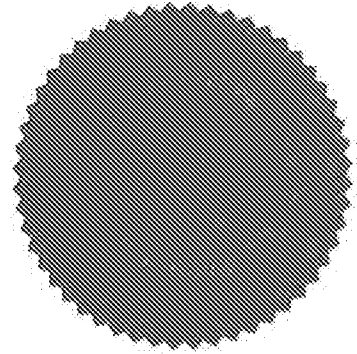


