
## BILL OF SALE, ASSIGNMENT, AND ASSUMPTION



Any rights to causes of action, suits, proceedings, judgments, investigations, claims, demands of any nature whatsoever and whenever maturing or asserted to the extent that they relate to the tangible and intangible personal property heretofore used in connection with the businesses and operations of Access Products Group or Music Express and conveyed to Newco.
6. All customer lists and customer prospect lists, and all supplier lists, product catalogues and brochures, and advertising and promotional literature and materials heretofore used in connection with the businesses and operations of Access Products Group or Music Express.
