UPON SAID CONSIDERATION, Assignor represents and warrants that Assignor has not previously conveyed any right or title to the Patent Rights to a third party, and has the right and title, and the undersigned below has authority to execute this Assignment, and to convey any and all right, title, and interest in the Patent Rights, and that Assignor has not conveyed nor will convey hereafter all or part of the Patent Rights to a third party.
