 - 1.2 The right to sue for damages and other remedies in respect of any infringement of such rights or other acts within the scope of the claims of the patent or similar protection, any published specification of the patent or similar protection, or accompanying any application therefor


irrespective of whether such infringement or acts took place before or after the date of this Assignment;

TO HOLD the same unto the Assignee and its successors and assigns absolutely.


2. This Assignment is to have an effective date of 31 December 2015.
