ASSIGNMENT

Pursuant to said Agreement and in consideration of the sum of GB£10.00 now paid by the Assignee to the Assignor (the receipt whereof is hereby acknowledged) the Assignor hereby assigns, releases and conveys to the Assignee with full title guarantee the Intellectual Property Rights, and the inventions therein (and any subsequent right or rights arising therefrom), and the sole and exclusive benefit thereof, the right, title and interest therein, and all the rights, powers, privileges and immunities conferred on the applicant thereof by the filing of the Intellectual Property Rights free from all incumbrances and including the right to claim priority from any one of the Intellectual Property Rights and to sue for damages and other remedies in respect of any infringement of the Intellectual Property Rights and any resulting Patent or Patents thereof, **TO HOLD** the same unto the Assignee absolutely.

2. The Assignor and the Assignee agree to execute any such further supplemental documentation as may reasonably be required by the Assignee in order to register the Assignee as proprietor of the Intellectual Property Rights at the respective local Intellectual Property Offices around the world (hereinafter referred to as the "Local Documents").
3. Each of the Local Documents and this Assignment shall be regarded as one and the same instrument and in the event of any conflict between the terms of any of the Local Documents and this Assignment, the terms of this Assignment shall prevail.
4. This Assignment shall be governed by the laws of England and Wales and the parties agree to submit to the jurisdiction of courts of England and Wales.
