ASSIGNOR hereby authorizes and requests the patent office of the country in which this Assignment is recorded to issue to ASSIGNEE or its successors or assigns, all patent applications and patents assigned hereunder.

ASSIGNOR hereby agrees to execute any papers, to provide any information, and to testify in any administrative or civil proceedings including litigation at the request of ASSIGNEE, its successors, assigns and legal representatives, when deemed by the ASSIGNEE to be essential to the ASSIGNEE's, its successors', assigns' and legal representatives' full enjoyment, protection, enforcement and title in and to the patent applications and patents assigned hereunder.

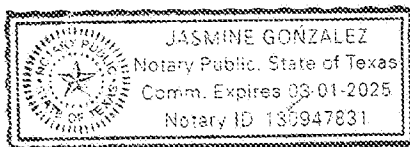
