PATENT RELEASE AND REASSIGNMENT

THIS PATENT RELEASE AND REASSIGNMENT is made as of August 14, 2023, by Varagon Capital Partners Agent, LLC ("Grantee"), in its capacity as Administrative Agent for the Lenders (in such capacity, "Grantee") in favor of CorEvitas, LLC, a Delaware limited liability company (f/k/a Corona, LLC, "Grantor"). Capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Patent Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Grantor, the other grantors from time to time party thereto and the Grantee entered into that certain Guarantee and Collateral Agreement dated as of December 13, 2019 (as amended, modified, restated and/or supplemented from time to time, the "Guarantee and Collateral Agreement");

WHEREAS, pursuant to the Guarantee and Collateral Agreement, Grantor and Grantee entered into that certain Patent Security Agreement dated as of December 13, 2019 (the "Patent Security Agreement"), pursuant to which Grantor granted to Grantee, for its benefit and the benefit of the Lenders, a continuing security interest in Grantor's entire right, title and interest in and to the following, whether then owned or existing or thereafter created, acquired or arising (collectively the "Patent Collateral"):

- (a) the Patent registrations and applications for Patents listed on Schedule I attached hereto, and
- (b) all goodwill and general intangibles of such Grantor relating thereto or represented thereby and all proceeds of the foregoing;

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on December 13, 2019 at Reel 051278, Frame 0328; and

WHEREAS, Grantor has requested that Grantee release its security interest in the Patent Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases without any representation, warranty, recourse or undertaking by Grantee, its security interest in all of Grantor's right, title and interest in, to and under the Patent Collateral.

2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by Grantee, any and all of Grantee's right, title and interest in and to the Patent Collateral, and authorizes the recordation of this Patent Release and Reassignment with the United States Patent and Trademark Office at the expense of the Credit Parties.
