RELEASE OF PATENT SECURITY AGREEMENTS

WHEREAS, pursuant to (i) that certain Patent Security Agreement, dated as of October 31, 2018 by Industrial Physics, Inc. (formerly known as Testing Machines, Inc.) and Illinois Instruments Inc. in favor of Sound Point Agency LLC (as successor in interest to CVC Credit Partners U.S. Direct Lending Fund II (RN) L.P. and CVC Credit Partners, LLC) (the “Agent”), recorded with the United States Patent and Trademark Office on November 1, 2018 at Reel 047383, Frame 0596 and (ii) that certain Patent Security Agreement, dated as of October 31, 2018, by Eagle Vision Systems B.V. (together with Testing Machines, Inc. and Illinois Instruments Inc., the “Grantors”) in favor of the Agent, recorded with the United States Patent and Trademark Office on November 1, 2018 at Reel 047383, Frame 0643, (each, a “Patent Security Agreement” and, collectively, the “Patent Security Agreements”, each of which was previously assigned pursuant to that certain Assignment of Security Interest in Patents Under Patent Security Agreements, dated as of May 1, 2020 and recorded with the United States Patent and Trademark Office on May 4, 2020 at Reel 052557, Frame 0808 and pursuant to that certain Assignment of Security Interest in Patents Under Patent Security Agreements, dated as of September 7, 2021 and recorded with the United States Patent and Trademark Office on September 20, 2021 at Reel 057524, Frame 0707), the Grantors granted a Lien on and security interest to the Agent in certain Patent Collateral; and

WHEREAS, the Grantors have requested, and the Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Patent Collateral, including the Patents set forth on Schedule 1.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Patent Security Agreements.
2. Release of Security Interest. Agent, without representation, warranty or recourse, hereby releases, relinquishes, terminates, cancels and discharges its continuing Lien on and security interest in the Patent Collateral, including without limitation, its continuing security interest in the Patent Collateral and hereby terminates the Patent Security Agreements.
3. Further Assurances. Agent further agrees to execute and deliver to the Grantors any and all further documents or instruments and do any and all further acts which the Grantors (or the Grantors’ agents or designees) reasonably request in order to confirm this release and the Grantors’ right, title and interest in and to the Patent Collateral.
