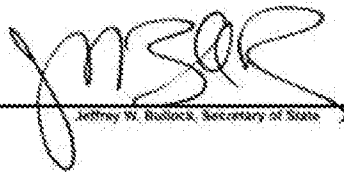

The corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware does hereby certify:

**FIRST:** That by unanimous written consent in lieu of a meeting pursuant to the By-laws and the General Corporation Law of the State of Delaware, the Board of Directors of Audentes Therapeutics, Inc. (the "Corporation") duly adopted resolutions setting forth a proposed amendment of Seconded Restated Certificate of Incorporation of said Corporation declaring said amendment to be advisable and directing its officers to submit said amendments to the sole shareholder of said Corporation for consideration thereof. The resolution setting forth the proposed amendment (the "Amendment") is as follows:
