ASSIGNMENT

THIS DEED OF ASSIGNMENT is made on 14th, day of December, 2018.

BETWEEN

- (1) **IMERYS MINERALS LIMITED** whose registered office is at Par Moor Centre, Par Moor Road, PL24 2SQ, Par – Cornwall, United Kingdom (the “Assignor”); and
- (2) **IMERTECH** whose registered office is at 43 Quai de Grenelle, 75015, Paris, France (the “Assignee”)

BACKGROUND:

- (A) The Assignor has agreed to assign the Intellectual Property Rights subsisting in and the Know-how relating to the Invention to the Assignee on the terms set out below.

AGREEMENT:

The parties **AGREE** as follows:

1. Definitions

In this Assignment unless the context otherwise requires:

"Intellectual Property Rights" means all patents, registered designs, trade marks and service marks (whether registered or not), copyright, database rights, moral rights, design right, and all similar property rights subsisting in or arising out of the Invention and Know-how, applications for any of the foregoing and the right to apply for any applications of the foregoing, the right to claim priority from any applications filed, and all industrial or intellectual property rights analogous to the foregoing and subsisting in the Invention and Know-how anywhere in the world including without limitation those listed in Schedule 1;

"Know-how" means know-how, research data, trial results, designs, knowledge and all other information, documents and material recorded in whatever form or medium relating to the Invention or the Assignee's business and including any information disclosed in a patent application;

"Invention" means the invention described in the draft patent application in Schedule 1 including any documentation, analysis, reports, drawings, design models, creative briefs, programs, prototypes, electronic representations (whether produced by computer or otherwise) and other material relating to such invention.

2. Assignment

In consideration of the payment of £1 by the Assignee to the Assignor, the Assignor assigns to the Assignee with full title guarantee free from all and any charges or other third party rights all his right, title and interest in the Intellectual Property Rights together with all rights of action, remedies, powers and benefits relating to any of the Intellectual Property Rights including the right to apply for a patent application for the Invention at the European Patent Office and in any other country or patent office of the world, including the right to claim priority from any patent application filed for the Invention, including all provisionals, non-provisionals, divisionals, continuations, continuations in part, reexaminations,

reissues and all other applications for any patent that shall be filed, issued or granted in any country on such inventions, including but not limited to utility models, designs, design patents, as well as envelope soleau and like rights of exclusion; and the right to sue for damages for infringement in any of the Intellectual Property rights.

3. Confidentiality

The Assignor shall keep and procure to be kept secret and confidential the Know-how and other confidential information acquired from or through the Assignee and will not use nor disclose the same save with the prior written consent of the Assignee.

4. Further Assurance

The Assignor undertakes that, at the request and expense of the Assignee, he will do all acts and things (including, without limitation, making declarations and oaths) and execute all documents that may be reasonably necessary under the law of any country for completing the transfer to the Assignee of the full right, title and interest to any of the rights assigned by clause 2.

At the request of the Assignee, the Assignor shall (at the Assignee's expense) provide all assistance to the Assignee which may be necessary in connection with bringing or defending any proceedings relating to any of the rights assigned by clause 2.

5. Applicable Law and Jurisdiction

This Assignment and any dispute or claim arising out of or in connection with it shall be governed by and construed in accordance with the laws of England and all disputes and claims arising out of or relating to this Assignment shall be subject to the exclusive jurisdiction of the English Courts to which the parties irrevocably submit.
