ASSIGNMENT

This PATENT ASSIGNMENT ("**Patent Assignment**"), dated as of April 5, 2023, is made by Covestro LLC, a Delaware limited liability company having offices located at 1 Covestro Circle, Pittsburgh, Pennsylvania 15205 ("**Assignor**") and The University of southern Mississippi, a not-for-profit state-supported educational institution with offices located at 118 College Drive #5050, Hattiesburg, Mississippi 39406 ("**Assignee**") pursuant to that Sponsored Research Agreement by and between the parties dated September 1, 2016 (the "**Agreement**").

WHEREAS, under the terms of the Sponsored Research Agreement, Assignor has elected to abandon the patents listed in Exhibit A (collectively, the "**Assigned Patents**"), including all foreign and domestic issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations, and renewals thereof; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, the entire right, title, and interest in and to the Assigned Patents, including:

- (a) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;
- (b) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and
- (c) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. Assignor hereby authorizes the Commissioner for Patents in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Patent Assignment upon request by Assignee. Following the date hereof, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Assigned Patents to Assignee, or any assignee or successor thereto.

3. Counterparts. This Patent Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Patent Assignment delivered by facsimile, e-mail, or other

means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Patent Assignment.

4. Successors and Assigns. This Patent Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

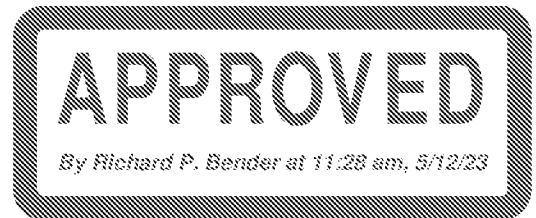
