It is expressly agreed by Assignor and Assignee that this Assignment fully conveys and transfers from Assignor to Assignee the right to sue for any and all patent infringement occurring prior to the date of this Assignment.

Assignor hereby requests that said Patents be issued in accordance with this Assignment.

Assignor further covenants and agrees that, at the time of the execution and delivery of these presents, Assignor possesses the unencumbered right and authority to make this Assignment.


