CERTIFICATE OF INCORPORATION  
OF  
METASTATIX, INC.**

This corporation was organized by filing its original Certificate of Incorporation under the name of "Metastatix, Inc." with the Secretary of State of the State of Delaware on June 30, 2006 and amended and restated on September 14, 2007 and on August 14, 2008. This Third Amended and Restated Certificate of Incorporation was duly adopted in accordance with Sections 242 and 245 of the General Corporation Law of the State of Delaware (the "*Delaware General Corporation Law*"),

**I.**

The name of this company is **Altiris Therapeutics, Inc.** (the "*Company*" or the "*Corporation*").
