AND WE DO HEREBY authorize and request the Commissioner of Patents and Trademarks to issue said Letters Patent, when granted, to the said ASSIGNEE, its successors and assigns, as assignees of the entire right, title and interest in and to said invention, for the sole use and behalf of said ASSIGNEE, and for its successors and assigns, to the full ends of the terms for which Letters Patent may be granted.

AND we further grant to ASSIGNEE, its successors and assigns, the right to claim for any application for patent for said invention the full benefit of any international agreement between the United States and any foreign country or countries

This Assignment may be signed in counterparts, each of which shall be deemed an original and each of which taken together shall constitute one assignment.


