**AFFIDAVIT**


Relating to the legal entity Naturex SA

In the context of group reorganization, Naturex SA will be renamed **Givaudan France Naturals SAS**, as from the 3rd of October 2022. Naturex SA will no longer exist as a legal entity name.

The above mentioned reorganization will have no impact on the company registration numbers (SIREN), the tax and VAT registration numbers, the plant locations, the products manufacturing process, the product names and quality, which will all remain unchanged.


