**CERTIFICATE OF AMENDMENT TO THE AMENDED AND RESTATED CERTIFICATE OF  
INCORPORATION OF LIONANO SE INC.**

Pursuant to the provisions of Section 242 of the General Corporation Law of the State of Delaware, Lionano SE Inc., a Delaware Corporation (the "Corporation"), in order to amend its Amended and Restated Certificate of Incorporation, as amended, hereby certifies as follows:

FIRST: The name of the Corporation is Lionano SE Inc.

SECOND: That the Board of Directors of the Corporation adopted resolutions setting forth a proposed amendment to the Corporation's Amended and Restated Certificate of Incorporation, as amended, declaring said amendment to be advisable and in the best interests of the Corporation and its stockholders and approving said amendment, which resolutions setting forth the proposed amendment are as follows:

**RESOLVED**, that it is in the best interest of the Corporation to amend its Certificate of Incorporation to change the name of the Corporation to "**Factorial Inc.**";

**RESOLVED**, that the Certificate of Incorporation of this Corporation shall be amended by changing the Article thereof numbered "First" so that, as amended, said Article shall be and read as follows:

"FIRST: The name of this corporation is Factorial Inc. (the "**Corporation**")"

**RESOLVED**, that the appropriate officers of the Corporation be, and they hereby are, authorized and directed to take all such further actions and to execute and deliver all such instruments and documents in the name and on behalf of the Corporation, and under its corporate seal or otherwise, as in their judgment shall be necessary, proper, or advisable in order to fully carry out the intent and to accomplish the purposes of the foregoing resolutions.

THIRD: That this Amendment was duly adopted and approved by the Board of Directors of the Corporation without stockholder approval on the 13th day of March 2021, in accordance with the provisions of Section 242(b) of the General Corporation Law of the State of Delaware.
