ASSIGNMENT AND MUTUAL TERMINATION AGREEMENT

THIS ASSIGNMENT AND MUTUAL TERMINATION AGREEMENT (the "AMT Agreement") is entered into by, on the one hand, Motedata LLC, and on the other, Motedata, Inc. (collectively referred to herein as the "Parties"). The effective date of this AMT Agreement shall be the date on which this AMT Agreement has been fully executed (the "Effective Date").

WHEREAS, the Parties entered into a January 9, 2020 Assignment Agreement (the "January 9 Agreement") under which Motedata, Inc. assigned to Motedata LLC U.S. Patent No(s) 7,388,488, 7,956,742, 8,314,705, 8,558,668, 8,952,814, 9,218,520, 9,460,233, 9,785,810, 10,459,930, 9,817,870, 10,331,920, and all United States patents, patent applications, continuations, continuations-in-part, divisionals, extensions, renewals, reissues, re-examinations and post-grant certificates related to all inventions thereof, (collectively referred to as the "Patents"); and

WHEREAS, Motedata LLC wishes to assign the Patents to Motedata, Inc.; and

WHEREAS, the Parties wish to terminate the January 9 Agreement, including all obligations thereunder;

NOW THEREFORE, the Parties agree as follows:

1. Termination

- a. The Parties hereby terminate the January 9 Agreement as of the Effective Date.

2. Releases

- a. **Motedata LLC Release.** Motedata LLC, on behalf of itself and its officers, members, shareholders and agents, hereby releases Motedata, Inc., and its officers, members, shareholders and agents from any and all claims, known or unknown, including, but not limited to, any and all claims, known or unknown, arising from or relating to the January 9 Agreement and/or the Patents.
- b. **Motedata, Inc. Release.** Motedata, Inc., on behalf of itself and its officers, members, shareholders and agents, hereby releases Motedata LLC and each of its officers, members, shareholders and agents from any and all claims, known or unknown, including, but not limited to, any and all claims, known or unknown, arising from or relating to the January 9 Agreement and/or the Patents.


3. Miscellaneous

- a. **Prevailing Terms.** If any conflict exists between the terms of this AMT Agreement and the January 9 Agreement, the terms of this AMT Agreement shall control.

- b. **Entire Agreement.** This AMT Agreement constitutes the entire understanding of the Parties with respect to its subject matter and supersedes any and all prior commitments, agreements, representations and understandings, whether written and/or oral, relating to the subject matter hereof. There are no oral agreements or representations between the Parties. This AMT Agreement may not be modified or amended, except in a signed writing by the Parties.
