The Assignor shall without further consideration do all such things and execute all such documents as may be necessary or desirable to obtain and maintain the Application(s) for the inventions, and all related applications and patents thereon, in any and all countries, and to vest title thereto in the Assignee, its successors, assigns and legal representatives or nominees.
