DECLARATION UNDER MANUAL OF PATENT EXAMINING PROCEDURE §323.01(c)

I, the undersigned, hereby declare:

1. I am the attorney of record for the above-referenced U.S. Patent Application (herein, the "Application"), by virtue of a Power of Attorney executed by Pie Medical Imaging B.V. (herein, the "Company"), a company existing under the laws of the Netherlands and having a place of business at Philipsweg 1, NL-6227 AJ Maastricht, Netherlands, which Power of Attorney was filed in the U.S. Patent and Trademark Office on August 15, 2017.

2. The Company is the Applicant named in the Application Data Sheet filed with the Application on August 15, 2017, and the current owner of record of the entire right, title and interest in and to the Application and the invention (the "Invention") described therein, by virtue of the Assignments described below.

3. The complete inventorship of the Application as set forth in the corrected Application Data Sheet filed May 30, 2023, consists of: Jean-Paul Aben, Chris Johannes Catharina Bouwman, Eduardo Soudah Prieto and Riccardo Rossi Bernecoli. Inventors' Declarations for all four inventors were filed in the U.S. Patent and Trademark Office on August 15, 2017, and May 30, 2023.

4. On August 11, 2017, inventor Prieto executed an Assignment document (herein, the "First Prieto Assignment") which purported to convey to the Company his entire right, title and interest in and to the Invention and the Application. Inventors Jean-Paul Aben and Chris Johannes Catharina Bouwman executed separate Assignment documents (herein, the "Aben and Bouwman Assignments") conveying to the Company their entire right, title and interest in and to the Invention and the Application on August 14, 2017, and July 24, 2017, respectively. On August 15, 2017, the First Prieto Assignment and the Aben and Bouwman Assignments were recorded in the records of the Assignment Recordation Branch of the U.S. Patent and Trademark Office at REEL/FRAME: 043297/0887.

5. At the time the Invention was made and at the time the First Prieto Assignment was executed, inventor Prieto was employed by CIMNE, INTERNATIONAL CENTRE FOR NUMERICAL METHODS IN ENGINEERING (herein, "CIMNE"), which is a non-profit public body research organization existing under the laws of Spain and having a place of business at Edifici C1, Campus Nord-UPC, C/ Gran Capità, s/n, 08034 Barcelona, Spain.

6. Under the terms of inventor Prieto's employment with CIMNE, he was obligated to assign his entire right, title and interest in and to the Invention to CIMNE.

7. Based on the foregoing, the First Prieto Assignment was erroneously executed and recorded and should be deemed nullified.

8. Upon elucidation of the facts set forth in paragraphs 5, 6 and 7 above, inventor Prieto and the Company signed an Agreement, effective as of May 10, 2023, declaring the First Prieto Assignment and any other purported assignment of rights, title, and interest in the Application by inventor Prieto to the Company to be null and void and of no force or effect whatsoever. A copy of such Agreement is attached hereto.

9. On May 11, 2023, inventor Prieto executed an Assignment (herein, the "Second Prieto Assignment") conveying to CIMNE all of his right, title and interest in and to the Invention and the Application. On May 11, 2023, inventor Riccardo Rossi Bernecoli also executed an Assignment (the "Bernecoli Assignment") conveying to CIMNE all of his right, title and interest in and to the Invention and the Application. On June 2, 2023, the Second Prieto Assignment and the Bernecoli Assignment were recorded in the records of the Assignment Recordation Branch of the U.S. Patent and Trademark Office at REEL/FRAME: 063845/0994.

10. On May 23, 2023, CIMNE executed an Assignment of Patent Rights (herein, the "CIMNE Assignment") conveying to the Company CIMNE's entire right, title and interest in and to the Invention and the Application. On June 2, 2023, the CIMNE Assignment was recorded in the

records of the Assignment Recordation Branch of the U.S. Patent and Trademark Office at
REEL/FRAME: 063846/0472.

11. Based on the foregoing, the Company is currently the owner of the entire right, title and
interest in and to the Invention and the Application.






