Assignment Agreement

AN AGREEMENT dated 11-5-2023 (the 'Effective Date')

BETWEEN

- 1) KOEPALA PACKAGING OY, company ID: FI27084494, Työpajankatu 2b E, 00580 Helsinki, Finland ("Koepala");
- and
- 2) GKS PACKAGING BV, Steenoven 18, 5626 DK Eindhoven, The Netherlands, Business ID: 17111742 ("GKS").

Koepala and GKS are referred to below together as the "Parties" and separately as the "Party".

NOW, THEREFORE, the Parties hereby agree as follows:

Article 1. Definitions.

Terms defined in the JDA are also used herein and are included in this assignment agreement (hereafter 'Agreement'). The following definition is added for the purpose of this Agreement.

"Koepala Intellectual Property Rights" means the patent and patent applications as further described in Annex A below.

Article 2. Assignment.

- 2.1. With effect from the Effective Date, Koepala hereby assigns and delivers to GKS who hereby accepts this assignment, all right, title, and interest to:
 - (a) the patent application with title 'package or product and a package or product roll' with application no. 20150005817, that has been filed with the Finnish patent office on the 6th of November 2015, and the patent application with title 'Package blank and a package' with application no. 20225440, that has been filed with the Finnish patent office on the 19th of May 2022 (the 'FI Patent Applications'), including;

- i. the right to benefit from any priority claimed based on FI Patent Applications, and to prosecute and obtain grant of patent;
- ii. the right to file divisional applications based on FI Patent Applications, and to prosecute and obtain grant of patent on each and any such divisional application;
- iii. the absolute entitlement to any patents granted based on FI Patent Applications or filed as aforesaid; and
- iv. the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of the FI Patent Applications' or any patents granted on om the basis of FI Patent Applications' or filed as aforesaid, whether occurring before on or after the date of this assignment.;

and

- (b) All the patents as listed in Annex A to this Agreement (hereafter referred to as the 'Assigned Patents'), including the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of the Assigned Patents.

all the foregoing under in this Article 2.1 hereafter referred to as the **Assignments**.

- 2.2. Koepala agrees to instruct its patent attorney(s) within one working day that the above-mentioned rights have been assigned and to accept instructions in respect of the above-mentioned rights from GKS and its patent attorney, and Koepala shall perform any acts, such as execution of documents, which may be required to effectuate the Assignment.
- 2.3. Furthermore, Koepala shall promptly but not later than 3 days as of the Effective Date provide GKS (electronically) with specifications regarding the FI Patent Application no. 20225440 as filed including the description and the claims in Word format as well as all the drawings as included in the FI Patent Application.

Article 3 Consideration.

For the Assignment (and obtaining all rights title and interest in the Koepala Intellectual Property Rights according to above Article 3) , GKS agrees to pay to Koepala a total sum of [REDACTED] within a term of 30 days after Assignment date, provided that Koepala has fulfilled all its obligations according to this Agreement, including without limitation the obligations according to Article 2.3.

Article 4 General.

- 4.1. Governing Law / Disputes. This Agreement shall be governed by and construed in accordance with the laws of the Netherlands. The competent court in The Hague, the Netherlands shall have exclusive jurisdiction to settle any dispute in connection with this Agreement.
- 4.2. Entire Agreement. This Agreement contains the whole agreement of the Parties relating to the subject matter and supersedes all previous understandings, written or oral, between the Parties or any pre-contractual statement relating to the same subject matter. This Agreement may not be modified other than by a written instrument executed by duly authorized representatives of the Parties.



- 4.3. Severability. All other terms and conditions of this Agreement shall remain in full force and effect and shall be construed in accordance with the modified provision.
