TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”) is made as of September 12, 2023, by **PACIFIC WESTERN BANK**, a California state-chartered bank (“Lender”) in favor of **SCIENCELOGIC, INC.**, a Delaware corporation (“Company”) with its principal place of business located at 11955 Democracy Drive, 13th Floor, Reston, VA 20190.

Recitals

WHEREAS pursuant to that certain (i) Loan and Security Agreement by and between Lender and Company, dated as of August 24, 2018 (as amended, the “Loan Agreement”) and (ii) Intellectual Property Security Agreement by and between Lender and Company dated as of August 24, 2018, and Supplements to Intellectual Property Security Agreement dated as of May 1, 2019, April 16, 2020, and July 14, 2021 (collectively, the “Intellectual Property Security Agreement”, and together with the Loan Agreement, the “Loan Documents”), and recorded with the US Patent and Trademark Office (“USPTO”) as set forth on Exhibits A and B, Company granted to Lender a security interest in the entire right, title and interest of Company in, and to all of Company’s right, title and interest in, to, and under the Intellectual Property Collateral.

WHEREAS Company has no outstanding obligations to Lender under the terms of the Loan Agreement, Lender agrees to release its security interest in the Intellectual Property Collateral.

Agreement

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Lender covenants and agrees as follows:

1. Defined Terms. Capitalized terms used herein but not defined herein shall have the meanings given to such terms in the Loan Agreement or Intellectual Property Security Agreement, as applicable.
2. Termination and Release. Lender, without representation, warranty, or recourse, hereby:
 - a. terminates the Intellectual Property Security Agreement and terminates, cancels, discharges and releases the mortgage, pledge, and hypothecation and liens on and security interests in and the entire right, title and interest of Company in, to and under the Intellectual Property Collateral (including without limitation those patents and trademarks listed in Exhibits A and B hereto), including without limitation all proceeds thereof, the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof, granted pursuant to the Loan Documents;


- b. reassigns, grants and re-conveys to Company, any and all of the right, title and interest of Company that may have been acquired in, to, and under any and all of the Intellectual Property Collateral; and
- c. authorizes the recordation of this Release with the USPTO, at Company's expense.
