AMENDED AND RESTATED

INTELLECTUAL PROPERTY SECURITY AGREEMENT TERMINATION

WHEREAS, goTenna, Inc. a Delaware corporation (“goTenna”), located at 81 Willoughby St., Floor 4, Brooklyn, NY 11201 (the “Grantor”), and Eastward Fund Management, LLC, a Delaware limited liability company, located at 432 Cherry Street, West Newton, Massachusetts 02465 (the “Secured Party”), entered into a certain Amended and Restated Intellectual Property Security Agreement, dated as of January 31, 2022 (the “Agreement”), which was recorded in the United States Patent and Trademark Office on February 4, 2022 at Reel 7623 and Frame 0877 for trademarks and at Reel 058896 and Frame 0939 for patents, that by its terms granted Secured Party a security interest in certain intellectual property including intellectual property listed in Schedules A, B, C, and D to this agreement; and

WHEREAS, the Grantor has or has caused to be paid and satisfied in full the obligations for which the security interest in the Agreement was granted.

NOW THEREFORE the Secured Party hereby reassigns to the Grantor the interest in the trademarks, patents, and copyrights listed on Schedules A, B, C, and D attached hereto in which Secured Party was granted a security interest under the Agreement. Secured Party also hereby releases all security interests granted in the Agreement and in Schedules A, B, C and D attached hereto. The Secured Party further agrees, for itself, its successors and assigns, to execute such further documents and to perform such further lawful acts as may reasonably be requested by the Grantor, to effectuate this termination.

IN WITNESS WHEREOF the Secured Party hereto by the signature below of its duly authorized representatives agrees to be bound by the provisions of this Intellectual Property Security Agreement Termination as of the date of execution, this 25th day of August, 2023.
