**TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS AND
TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS**, dated as of September 15, 2023 (“Release”), is made by **FIDUS INVESTMENT CORPORATION**, a Maryland corporation, as Grantee (“Grantee”) in favor of **HALLMARK HEALTH CARE SOLUTIONS, INC.**, a Delaware corporation (“Grantor”), pursuant to that certain Security Agreement dated December 4, 2020 (as amended, modified, restated or supplemented from time to time, the “Security Agreement”);

WHEREAS, in connection with the Security Agreement, Grantor executed and delivered a certain Intellectual Property Security Agreement, dated as of December 4, 2020 (the “Patent and Trademark Security Agreement”), which is recorded at the United States Patent and Trademark Office (“USPTO”) on December 18, 2020 at Reel 054693 Frame 0347 and Reel 007143 Frame 0930 (“Notice”), whereby Grantor granted to Grantee, a continuing security interest in any and all of Grantor’s right, title, and interest in and to Patents and Trademarks, including those Patents and Trademarks listed on Schedule A attached hereto;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Patent and Trademark Security Agreement.

SECTION 2. Termination and Release. Grantee, without representation, warranty, or recourse, hereby irrevocably terminates, cancels, discharges, and releases the continuing security interest in Grantor’s right, title, and interest in and to the Patents and Trademarks granted pursuant to the Patent and Trademark Security Agreement and the Notice. The Grantee hereby authorizes the Grantor, and any of their designees, to file this Release with the USPTO and/or any other applicable governmental office or agency to evidence the release and termination of the security interest in the Patents and Trademarks contemplated hereby. Grantee agrees to execute and deliver to the Grantor all other instruments and other documents as the Grantor may reasonably request to release the security interest in the Patents and Trademarks which had been granted under the Notice, in each case, at the sole expense of the Grantor.
