AND THE SOLE RIGHT to file applications for patents under the patent laws of any country in the world in its name, and the sole right to have patents granted on said U.S. and foreign patents and applications in its name to the full end of the term for which same would have been held by CERNER CORP., had this assignment not been made, and to enforce said patents with the right to sue for and recover for its own use accrued profits or damages for any

and all infringements thereof, including, but not limited to, past infringements with respect to which CERNER CORP. hereby waives any rights to receive any portion thereof.
